Investment Overview

Provides a portfolio of at least 80% municipal securities, and at least 80% investment-grade securities, with an average maturity of between 3 and 10 years. Seeks high current income exempt from Federal income tax. Emphasizes team management and extensive credit research expertise to identify attractively priced securities.

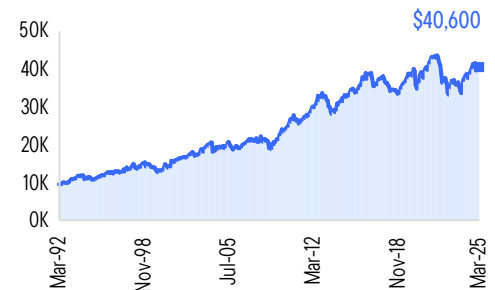

Credit Quality is a measure of a bond issuer's ability to repay interest and principal in a timely manner. What should I know before investing?

Glossary

Average Life: An estimate of the number of years to maturity, taking the possibility of early payments into account, for the underlying holdings. **Effective Duration** is a duration calculation for bonds with embedded options. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Duration measures the sensitivity of price (the value of principal) of a fixed-income investment to a change in interest rates. The higher the duration number, the more sensitive a fixed-income investment will be to interest rate changes. **AMT Exposure** measures the percentage of a fund's assets invested in bonds with income subject to the alternative minimum tax (AMT). **Average Coupon** is the average interest rate stated on the securities held by a portfolio.
