Glossarv

Duration measures the sensitivity of price (the value of principal) of a fixed-income investment to a change in interest rates. The higher the duration number, the more sensitive a fixed-income investment will be to interest rate changes. Average Coupon is the average interest rate stated on the securities held by a portfolio.
