Investment Overview

Provides a non-leveraged high-yield corporate fixed-income portfolio with a limited term structure that will liquidate on or about September 30, 2025. Seeks high income, with capital appreciation as a secondary objective. Emphasizes team management and extensive credit research expertise to identify attractively priced securities.

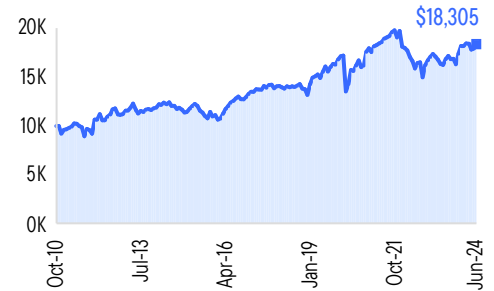

What should I know before investing?

Glossary

Average Life: An estimate of the number of years to maturity, taking the possibility of early payments into account, for the underlying holdings. **Effective Duration** is a duration calculation for bonds with embedded options. Effective duration takes into account that expected cash flows will fluctuate as interest rates change. Duration measures the sensitivity of price (the value of principal) of a fixed-income investment to a change in interest rates. The higher the duration number, the more sensitive a fixed-income investment will be to interest rate changes. **Average Coupon** is the average interest rate stated on the securities held by a portfolio.
